This funding will allow us to be able to hire a full-time social worker that will be able to service all students with social emotional issues that we are seeing come up in all student populations across the board during the COVID-19 pandemic. Our school also has a large Special Education and LGBTQIA population, so any project that the ARP funding goes to helps to ensure that we can provide these opportunities to students that may not be able to participate in with larger schools. We are also utilizing funding for after school tutoring and summer school/credit recovery since many students are needing more and more of these services since the COVID-19 shutdown. We will be able to have more teachers offer tutoring with this additional funding and can focus on all students, rather than just those in greater need of those services. Our McKinney Vento program also usually does not see any additional help or funding come in as it is small. We have seen an increase in students that qualify for this program and we will be putting aside additional funding from the ARP funds to help this program.</p>

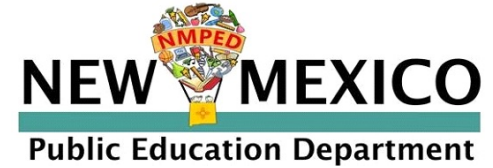

(2) EXCEPTION.—Paragraph (1) shall not apply to a local educational agency in fiscal year 2022 or 2023 that meets at least 1 of the following criteria in such fiscal year: (A) Such local educational agency has a total enrollment of less than 1,000 students. (B) Such local educational agency operates a single school. (C) Such local educational agency serves all students within each grade span with a single school. (D) Such local educational agency demonstrates an exceptional or uncontrollable circumstance, such as unpredictable changes in student enrollment or a precipitous decline in the financial resources of such agency, as determined by the Secretary of Education</p>	False

**Instructions:**

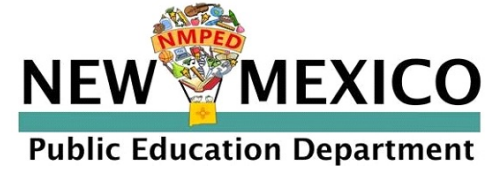
